Technical info

Fluorescent and with reflective tape. The surface treatment makes the product dirt-repellent. Two-toned. Triple stitched seams at leg and crotch. Belt loops. Fly with zip. Front pockets. Reinforced back pockets - one with flap and hook and loop band fastening. Adjustable hammer loop. Thigh pocket with several compartments, flap and adjustable hook and loop band fastening. Ruler pocket. Thigh phone pocket with flap and adjustable hook and loop band fastening. Pen pockets. Kneepad pockets. We recommend 00718-100, 50451-916 and 20118-915 kneepads for this model. Co-certified together with kneepad type LONG in accordance with EN 14404.

- Workwear logo. Horizontal on left thigh. Max 11x5 cm/4.3x1.9 inches
- Workwear logo. Vertical on right thigh, read from the top downwards. Max 15x5 cm/5.9x1.9 inches
- Workwear logo. Horizontal on right thigh. Max 11x5 cm/4.3x1.9 inches
- Workwear logo. Horizontal on right calf. Max 12x6 cm/4.7x2.3 inches
- Workwear logo. Inside waistband. Max 15x1 cm/5.9x0.3 inches
